It succeeded the National Board of Scientific and Technological Research (JNICT), which operated between 1967 and 1997

Since 2013, it has also taken on responsibilities related to National Scientific Computing


Science and Technology Archive



The Science and Technology Archive processes, preserves and promotes the archival heritage into the custody of FCT, keeping alive the memory and history of science and technology in Portugal. In other words, it can be said that it preserves the essence of the scientific activity carried out in

Portugal.

- Maintain and manages documentation of undeniable interest and historical quality;
- Reflects Portuguese cultural and scientific activity, essentially from the second half of the 20th century onwards;
- The content is largely translated into thousands of support files for grants, institutions, research projects, among others;
- Documents that represent the history of institutions, scientific policies and the organization of science, with interest for all areas of knowledge;
- It has also been integrating Archives of scientists and researchers with relevant activity in national and international scientific scene.



Current content

- 11 institutional archives representative of safeguarding and promoting the memory of administrative management in support of science;
- > 6 personal archives of scientists and science-related figures;
- Scientific production translated into thousands of theses, articles, publications, scientific reports...;
- Manuscripts, press clippings, editions, photographic collections, drawings, periodicals and monograps ...;
- Scientific Video Club;



- The inventory was created on a system that complies with international requirements for archival description and allows the association of digital objects and making them available online through the registration of association description.
- The scanning and online availability of documents is a goal that lies ahead in the near future as part of the activities of the Science and Technology Archive, for reasons of accessibility and availability of information but also for reasons of preservation.

The structure of the inventory is based on the international standards:

- 1. ISAD(G) International Standard Archival Description
- 2. EAD Encoded Archival Description
- 3. ISAAR (CPF) International Standard Archival Authorities Records
- 4. EAC Encoded Archival Context
 - The first two are intended to support the process of archival description. The others are designed to support the production of authority records.
 - In both cases encoded XML files were produced according to standard text structures in EAD and EAC and therefore allowing international exchange and dissemination.

O ACT tem também integrado e disponibilizado arquivos de cientistas e investigadores e de outras personalidades ligadas à investigação científica, em Portugal.






DOCUMENTA, the Electronic File Management System for FCT
