### CristinaA:

- last week the second EMI 1 Update (EMI 1 Update 2 (23.06.2011) containing CREAM/CEMon revision update. It is under EGI verification .
- Discussion with Massimo about grouping CREAM & CEMon under the same task, in the future updates Cristina to ask Balazs (also to open task)
- Discussion with Maria about doing the same thing for all the products mentioned in the DNA1.3.2 as being in phase-out, Massimo clarified that phase-out means that no new functionalities will be added, but the maintenance of this products will not be stopped.
- A new Update cycle is starting today in the agenda there is the link to Certified & Verified products: StoRM, L&B, Proxyrenewal, MPI, UVOS

- Oliver questions about packages present in EMI & EPEL:
  - short-term question for Mattias if he has seen the list prepared by RicardoR containing all the packaging inconsistencies between EMI & EPEL and weather he think that they can work together to sort them out
    - Mattias agrees that we should work together to solve any inconsistencies. When he did
      the packages he tried to do the same kind of split as the ones done by PTs, but there

- were cases when he had to follow the guidelines, like in the case of VOMS. Usually he sends any kind of patches attached to some savannah tkts, some of them are there since quite some time.
- Oliver would like to know that they can count on Mattias to help on synchronization and on how to rationalize the naming.
- Mattias he was in contact with many people using different channels. He always spoke
  with one team at a time. He propose to have some organized meetings when everyone is
  involved.
- o long-term where the project is going with respect with this issue? He understood that the aim of the project is to remove this inconsistency of having to manage 2 separate sets of packages, would like to know how we will get there, what objective is to release EMI packages through EPEL?
  - Mattias we should put as much as possible in EPEL, the problem is that this means that one has to comply with the update policies in the distributions.
  - Oliver that's why we need to have representatives from both side to try to understand how this should be done.
  - Mattias this should be a dedicated meeting, not EMT-one
  - Oliver Cristina to put an action on Mattias and Oliver to try to progress in this direction
- Cristina for the WLCG conference, 11 13 July, there will be a presentation about EMI Deployment Planning, the request is to have information from PTs about how to migrate services, what is important to keep in mind when doing DB migrations, and all other details that are important actions will be opened where some small reports, 1,2 slides can be added.
