Grid Site Operations

- https://edms.cern.ch/document/726129
 - Draft V0.9, 9 Jan 2007
- Document with a long history (JSPG started June 06)
 - Presented to GDB on (at least) three occasions
 - Discussed at length on e-mail lists
- Following Jan 07 GDB
 - Document went into "final call" for comments before approval
 - But we knew we needed final round with lawyers
 - Sent to GDB, EGEE ROC Managers, EGEE OSCT
 - And Site Security Contacts



Site Policy (2)

- To be signed by all sites during registration process
 - We also need all existing sites to sign
- The need for an authorised signature concentrates the minds of sites
- Received very few (zero?) comments from
 - GDB
 - EGEE ROC Managers
 - JSPG
- All comments came in from site contacts



Site Policy (3)

- OSG (Ruth Pordes)
 - Does not yet approve
 - No representation on GDB
 - Does not want LCG MB to approve before OSG
 - Fed back comments
- NDGF approves v0.9
 - But will consider again if it changes
- EGEE
 - Comments received from ~8 sites



Site Policy (4)

Main comments:

- If it is an agreement, two parties need to sign
 - Where are the obligations on the "Grid"?
 - The agreement should be time limited
- Its all too vague
 - What is the "Grid"?
 - Where are the Security Policies?
- We can't agree to Security Policies which can change in the future
- Comments received from WestGrid (Canada)
 - Similar comments to other sites but raises question...
 - What is their status re policy?



Site Policy (5)

- There is no reference to operational procedures
- Our University wants to know
 - What is this Grid?
 - What does it do for us apart from open us up to security problems?
 - What guarantees can the Grid give on software quality control?
- Should be an agreement *between* Grid sites for mutual protection
- You can't force us to apply security patches
- NREN should be involved
- Need to build trust between Grid and Sites



Site Policy (6)

- Yesterday we met again with CERN lawyers
- Suggested title change
 - Not an agreement
 - "Conditions" may be better
 - Grid Site Operations Policy
 - Conditions that apply during participation
 - Not just at registration
- They have also suggested massive simplification to the wording
 - Simpler and shorter
- JSPG needs to work more on this text
 - Then seek OSG and EGEE approval before coming back to GDB



Site Policy (7)

- Lesson learned
 - EGEE, OSG and GDB consultation does not involve the sites
 - Wider consultation during preparation of policy
 - Tier 2 sites are very different from Tier 1's
- We need
 - Covering note per Grid explaining the terms of the policy and pointers to policy docs etc
 - A document explaining how JSPG prepares policy and how stakeholders are consulted (we must tie sites to future changes in policy)



Other topics

- Accounting Data Policy
 - This is still top-priority
 - Monitoring Data also needs policy
 - Early draft in 2 weeks
- New VO Policy document
 - An agreement that VO's sign during registration
 - Similar to the Site Operations policy
- New Grid Service Policy document
 - Responsibilities of those who run services
- Next face to face JSPG will be at CERN
 - on 13/14 March 07



Requests to GDB

- Please comment on the *Grid Site Operations Policy*
 - When JSPG has agreed
 - And approve after OSG and EGEE have approved
- Comment on new *Grid Security Policy*
 - shown in Jan 07
 - We should aim for approval as soon as we can
