SIG-CISS : suggestions for specific topics

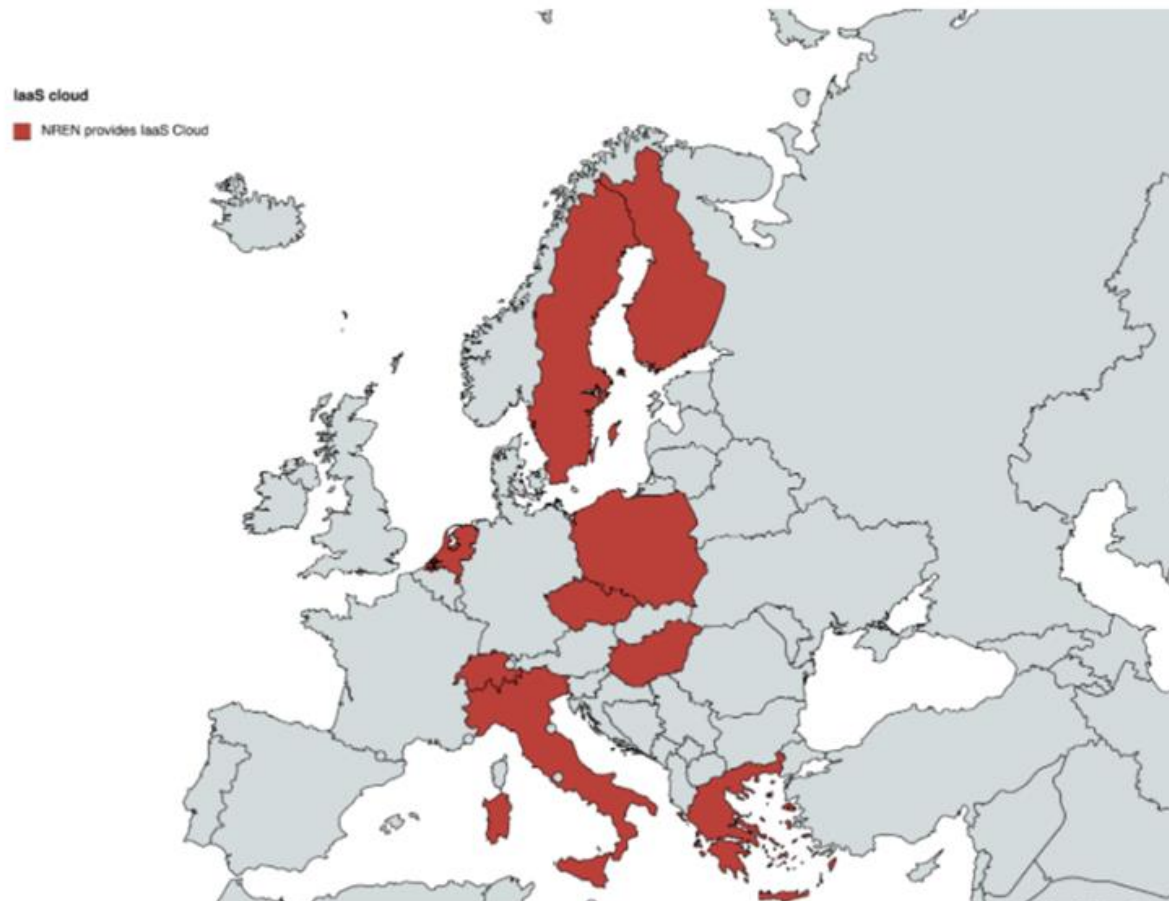
- Next SIGs: possible topics to focus upon
