- Better distribution of funds

IUPAP should engage more proactively with industry partners, policymakers, and other stakeholders to develop strategies for supporting industrial advancements through physics-based solutions.

#### Communication

#### Currently:

Unclear budget and marketing strategy

Inconsistent use across platforms

C14 - 4000 CHF newsletter??

Create a clear strategy for communications.

- Allocate a budget 5-15%
- Adopt best practices for accessible communication
- Collect and track data on communications metrics such as downloads and use this to test success of any approaches.

Consider establishing an e-newsletter (c.f., science in Public Australia physics newsletter).

Use digital platforms to hold webinars to enable better communication and elevation of IUPAP outputs.

#### **Finances**

Allow for flexibility in the payment period in order to reduce financial burden to territorial members that are struggling. For instance, to pay in advance for 2/3 years instead of annually.

Engage professional advice on the investment portfolio to identify investment options to IUPAP's finance committee (or equivalent) for purposes of providing funds for growth. IUPAP would then consider their tolerance of investment risk, desire for portfolio growth vs. maintenance of their capital, etc.

IUPAP should request extension of the tax exemption granted in the period 2021 – 2025 so as to maintain the current funds collected from membership revenue.
