






- 63% more ITs than in 2022
- **36% more** MSs than in 2022
- 10% less DOs than in 2022 (lack of time)







Cast-resin dry-type power transformers and switchboards



Vessels for gaseous helium at P1 and P5












Industrial return coefficient for supplies

Based on payments

Industrial return coefficient

For Supply contracts and for a 12-month period starting on 1st March, defined as:

"The ratio between a Member State's percentage share of the value of all Supply contracts during the preceding 4 years and that Member State's percentage contribution to the CERN Budget over the same period".

Excluding:


- ✓ Purchases funded by non-Member States (i.e. non CERN money)
- ✓ Purchases originated in non-Member
 States (US, CN, etc)

Status definition

Over a 4-year period:

- Very poorly balanced: < 0.40 (not defined in PR as such)
- Poorly balanced (PB) : $0.40 \ge x < 1$
- Well balanced (WB): ≥ 1


Industrial Return to Member States, supplies Status from 1 March 2024 – 28 February 2025



Industrial Return to Member States, supplies Status from 1 March 2024 – 28 February 2025

- New Procurement Rules should help with enhanced Limited Tendering mechanism
- Same number of VPB than last year BUT PK and UA have reached their "ceiling" in 2024, no new contracts will be placed in 2024
- CERN objective for 2025
 (max 3 VPBMS) is well on track, taken into account UA and IL situation, as well as AMSes reaching their ceiling
