1. Introduction. S. Bertolucci, Director of Research and Scientific Computing

S. Bertolucci welcomed delegates to the meeting.

2. Approval of the minutes of the last meeting. S. Bertolucci, Director of Research and Scientific Computing CERN-RRB-2013-060 (report) The minutes of the last ALICE RRB were approved without comment.

3. Status of the experiment. P. Giubellino, Spokesperson CERN-RRB-2013-112 (report), CERN-RRB-2013-113 (presentation)

J.Äystö asked when a concrete timescale with a money matric will be available.

P. Giubellino replied that this depends on the time taken by the publication and approval of the TDRs. After this the MoU can be produced. This is expected in the course of next year, before construction commences. We have a picture of what is being asked by whom. All projects consist of strong groups with support from FAs.

4. LHCC Deliberations (paper only). S. Bertolucci, Director of Research and Scientific Computing (replacing E. Tsesmelis, LHCC Scientific Secretary). CERN-RRB-2013-114 (report)

The LHCC considers that ALICE has made excellent progress, despite some operational issues, and the Committee congratulates the ALICE Collaboration on its achievements.

5. Financial matters. T. Lagrange, Head of CERN Finance and Procurement Department CERN-RRB-2013-115 (report), CERN-RRB-2012-116 (presentation).

T. Lagrange presented the updates to the Financial Report.

A number of additional contributions to the Construction Common Fund, Commissioning and Integration have been received totalling 83 kCHF. Outstanding contributions from Germany, the United Kingdom,, Korea, Pakistan and Turkey total 200 kCHF.

A number of additional contributions have been received for M&O-A totalling 363 kCHF. This leaves outstanding contributions for M&O-A for the year 2013 at 273 kCHF for member states and 190 kCHF for non-member states.

The total outstanding contributions are 495 kCHF, which amounts to 9.8% of the total, similar to the other LHC experiments.

There were no questions arising from this presentation.

7. Budgets. C. Decosse, ALICE Resource Coordinator

K.A.P. Sinha asked for clarification of the way the M&O A 'energy rebate' entitlements are calculated (slide 13).

C. Decosse replied that countries that contributed to the LHC construction do not pay the same amount. The entitlement for the 'energy rebate' is specified in the MoU. Member states are not billed for energy since it is deemed they have already paid for this by their member state contribution to CERN.

M&O Scrutiny Group Report, C. Touramanis, Chair. CERN-RRB-2013-120 (report)

The Scrutiny Group recommends approval of the ALICE 2012 M&O A & B closing reports (CERN-RRB-031) and the 2014 M&O A&B budget requests (CERN-RRB-2013-117 and CERN-RRB-2013-118).

The RRB subsequently:

- Approved the Alice 2012 M&O A&B closing reports and the 2014 M&O budget requests
- Approved the Addendum 35 to the MoU for Common Fund for the Upgrade of the Alice Detector
