
In November 1977 an Advisory Committee of CERN Users (ACCU) was set up with the task of advising the Director General on the practical measures and the administrative internal arrangements to be taken by the CERN Management for the utilization of the CERN facilities for research.

- Typically 4 meetings a year (Mar / Jun / Sep / Dec)
- Representations in committees:
 - Academic training committee
 - Accommodation facilities working group
 - IT service review meeting
 - Restaurants supervisory committee
 - Scientific information policy board (M. Weber)

Health insurance for users

- ACCU #98 (Dec12)→ Two schemes with collective contracts
- ACCU #99 → CHIS/UNIQA recalled
 - CHIS/UNIQA health insurance scheme → for MPE's
 - Not designed for MPAs, not suited for MPA's (users)
- ACCU #100 → Some legal issues raised
- ACCU #101 → New scheme with MPA as subscribers (Non urgent medical cares were not covered)
- ACCU #102 → New request incl. NATO statement
- ACCU #103 → New scheme incl. non urgent cares
- ACCU #104 (Jun14) → Some legal matters solved-out
- → Good coverage, not expensive... Let's see...


Transfrontalier insurance

- The issue is still being pursued

 - Still unofficial, but it looks like Swiss users with transfrontalier permit do not fall into category 1) but they fall into category 3) of the document.
 - 3) S'agissant du conjoint d'un fonctionnaire international ou d'un autre membre de famille (ressortissants suisses ou comunautaires), ils sont affiliés à la sécurité sociale dans le pays d'emploi dès lors qu'ils exercent une activité salariée ou non salariée, conformément au règlement (CE) 883/2004. S'ils travaillent en Suisse et résident en France, en tant que travailleurs frontaliers, ils bénéficient du droit d'option franco-suisse et seront intégrés dans le régime général de sécurité sociale à partir du 1^{er} juin 2014 s'ils avaient opté précédemment pour une assurance privée en France. En revanche, s'ils avaient opté précédemment pour une affiliation en Suisse, leur situation restera inchangée après le 1^{er} juin 2014 et ils continueront de relever de la LAMal. S'ils exercent une activité en France, ils continueront de relever d'un régime français de sécurité sociale.
- Ask the ACCU representative to forward unresolved questions to ACCU (the ACCU secretary promised to follow up)

"Near miss" reports

- Even if it is called "Accident report" near misses should be reported via the EDH form
- EDH under "Other"
- It will be followed up by the appropriate people
- Example Prevesin entrance:

 a redesign of the traffic (bike path, intersection) is considered but delayed by French elections. For the traffic light (reports of near misses) a short term solution is being investigated by CERN
