31 The ESC group is working on enhancing support in general and user support in particular.
32
33 At present when a ticket enters GGUS, the team at GGUS deals with it. They either close it themselves, or they steer it to an appropriate place. However there are times when the appropriate place is not clear. We expect that the introduction of gLite will give rise to more instances of this problem. What we wish to do is to have a second line of support, and the team at GGUS can allocate the ticket to the second line of support. Once a ticket has been processed in this way, the knowledge base at GGUS will be updated, so that similar tickets can be steered correctly by GGUS.

35 We propose making the second line of support a rotating responsibility. We wish to have a list of named individuals who have considerable experience of dealing with grid related problems of a user nature. (The CIC will deal with operational problems). If your ROC wishes to participate in this, then can you please nominate suitable persons. We will arrange a rota to suit the named individuals and deal with the individuals directly.

37 I am expecting that the first few weeks of this may be a bit painful, as we get to understand what we are doing. So we will allocate the most experienced people to this time, and will review our procedures in the light of experience.

39 If you wish to participate in this process, then please send me an e-mail. We can then discuss the arrangements in more detail.

41 We will start this arrangement on 7 March 2005 (EGEE week 49) and try this for 21 weeks until 29/07 (EGEE week 69). We will review it in July in the light of experience.
