Conclusions/Remarks

Enabling Grids for E-sciencE

- Work performed by 11 partners is going to be concentrated to 2 people.
 - Policy-related work, external relations and standardization should reflect the views and input of EGI partners
- Policy and external relations jointly require a bit more than 3 FTEs in EGEE, compared to 1 FTE in EGI
 - These tasks comprise activities at a high policy level
 - (interacting with policy fora and other projects, EC, collaboration strategy, etc.) and activities that are more oriented to administration (keeping track of policy contributions, keeping track of related projects).
 - Is the "Policy and External Liaison Manager" a kind of "Ambassador" of the project? (We think so). If yes, the administration activities should be carried out under his/her supervision by additional person(s).
