



Visitor's Information Guide

Welcome to the Soreq Nuclear Research Center!

A wide range of research and development projects are undertaken at SNRC, on various subjects including the production and handling of radioactive and chemical materials, use of lasers, and more.

All activity carried out at SNRC adheres to Israeli laws and regulation. In addition, the SNRC strictly abides by relevant international guidelines and standards.

Any risk to visitors or employees of the SNRC is mitigated by the Center's safety and security authorities, strict safety guidelines and security means placed around the operating centers and laboratories.

All visitors of the SNRC are required to uphold the following safety and security guidelines:

- Proper identification (passport, ID card) is required in order to enter the SNRC.
- Visiting hours at the SNRC are 8:00 – 16:00. Any deviation from visiting hours requires authorization given in advance from the SNRC Security Department.
- No cellular phones with installed cameras are allowed inside the SNRC. These phones must be deposited at the entrance to the SNRC.
- The Visitor's Badge must be worn in an easily distinguishable manner throughout the visit. The Badge must be returned at the gate upon exit.
- No unescorted movement in and around the Center is authorized. Any exceptions must be cleared with the Security Department in advance.
- No entrance into secured and screened -off areas is allowed without prior security clearance.
- No photographic/optical/recording equipment is allowed inside the Center.
- No computers or magnetic media of any kind are allowed inside the Center without prior authorization from the Security Department. SNRC equipment must not be removed from the Center without security authorization.
- No weapons of any kind are allowed into the SNRC without prior authorization from the Security Department.

- No handling or touching of any computers or operating machinery, safety or security equipment are allowed without prior coordination or authorization.
- Please pay close attention to all signs and notices around the SNRC, and to any and all instructions given by SNRC accompanier.
- When visiting certain areas in the Center, you may be requested to wear special protective clothing, as well as a Radiation Dosimeter Badge to monitor exposure to radiation. Please do not damage any of the equipment provided to you, and please return them prior to exiting the facilities.
- When driving within the Center, please adhere to all traffic regulations and signs. Please park your vehicle in the designated areas.
- If any directives are not clear or are not understood, please request explanations and instructions from your accompanier assisting you.
- Should sirens are activated during your stay at the Center (distinguishable from the alarms going off at the nearby Air Force Base), please adhere to all instructions given to you by your accompanier, and move quickly towards a secure area.
- The SNRC has specially trained safety and security authorities. In case of any accident, disruption or security incident, please adhere to all instructions provided by the authorities. The Safety Department can be reached at 08-9434100. The Security Department can be reached at 08-9434500.
