



Report on M&O Budgets

1 - M&O A Expenses in 2008

Table 1 presents a summary of 2002 - 2008 category A M&O invoices, income and amounts outstanding by Funding Agency as December 31st, 2008.

A breakdown of the 2008 Maintenance & Operations budget and expenditure is given in table 2. In addition, during 2008 an amount of 453 kCHF has been paid on commitments from the previous year.

Table 3 gives a summary of income, expenditure and balance of the M&O A accounts for the period 2002 – 2008.

2 - M&O A Estimates 2010 - 2012

The ALICE Maintenance and Operations category A budget 2009 and cost estimates for the period 2010 – 2013 are summarized in table 4.

3 - Preliminary Estimate for M&O A Expenses in 2010

Based on presently available estimates of the 2009 M&O category A cost and the sharing as determined in September 2008, a preliminary estimate of the 2010 budget and sharing is presented in Table 5.

The budget and sharing will be updated during 2009 and presented to the Resources Review Board in October 2009 for approval. The unused budget for energy in 2008, which has been invoiced to Non Member States Funding Agencies, will be deducted from the 2010 invoices.

4 - Category B Estimates

Table 6 shows estimates of Category B M&O budget requirements for the period 2010 – 2013. In a number of cases the data has been updated with respect to those presented to the Resources Review Board meeting on November 12, 2008. The data will be reviewed during 2009 before being presented to the meeting of the Resources Review Board in October 2009 for information.

Table 7 shows the 2010 preliminary M&O B budget by funding agencies and system.
