- Documents must also be registered to H2020



Committment to Open Access Publication of Kesults



For more information concerning CERN's Open Access policy, please familiarize yourself with the Open Access publishing rules and opportunities made available on the CERN library site before publishing.










Data Sets


- Contents for resource statements and activity reports to be provided via MS Word templates via the EASITrain collaborative Web site
