Software Licensing Task Force

Brief history



- Launched in June 2017 with guidance and recruiting by T. Kuhr. 3 meetings since then.

Charge to the Task Force



1. Get an overview of licenses of software we are using
 2. Determine a compatible license
 3. Agree on software ownership / contributors agreement
 4. Get agreement from contributors / owners
 5. Implement license in the software
- 1. Largely done.
 - 2. Unresolved. More permissive than GPL would be attractive, but GPL may be necessary.
 - 3. Preparation of an agreement is a work in progress (M. Ritter).
 - 4. Not started.
 - 5. Not started. Must wait for resolution of #2.



License selection status



- Initially the task force recognized a need to adopt a single license for all of the collaboration's software. Simplicity?
- In view of move by LHC organizations to utilize GPLvX in conjunction with APACHE licenses, the task force will reconsider.



License selection status



- In the licensing business do the same problems have the same solutions? Must each organization resolve the issues independently?
- Belle II does not seek to innovate in this area. Our strong preference would be to let the dust settle in the rest of the Universe and follow the leaders.
- The task force welcomes the opportunity to cooperate with HSF.
- We anticipate that valuable guidance will flow from HSF to the task force.



Copyright ownership and management



- The task force recognized the need to minimize the number of copyright owners.
- It also recognized a related need for an organization to serve as copyright custodian/manager.
- Given the relationship of Belle II Collaboration to KEK, the task force has offered KEK first refusal on the custodian/manager role.
- This role is not a natural fit for KEK. We raised the issue with KEK in late Jan. Their answer is pending.



Milestones calendar



- Important outstanding questions for the task force:
 - What are the drivers of the calendar? Given that we must ultimately attach licenses to Belle II software, how long can we defer before we go to prison?
 - Specifically, can we afford to wait until the big boys have resolved all of the licensing issues so that we may follow their lead?
 - Have the big boys reached or nearly reached asymptopia? What is their timeline?
 - What milestones should we set, and on what time scale must we achieve them?
