## 1- The EuCARD Project in brief

- Initiative of ESGARD, building up on FP6-CARE
- <u>Collaborative R&D in accelerator sciences</u> throughout Europe on topics defined of **highest priorities** by European Strategy Group for Particle Physics & ESFRI Roadmap.
- FP7 « Integrating activities » (JRA's, NA's, TA's) aiming at the upgrade of existing infrastructures (accelerators and test stations)
- 37 partners & 40 « associates », CERN coordinator
- 11 Work packages, 28 tasks + coordination tasks
- Resources: ~ 50 FTE's (232 persons involved) & 31 M€ over 4 years, including 10M€ EC funding



(except TA users)








Persons involved per participant











# 2- Activities of management bodies

- <u>Coordination office:</u> Meets every second week; organization, contractual issues, finance, reporting (S1+S2), communication & tools, meetings, support to workshops, support to partners, contact with EC.
- Governing Board: met 1/4/2009; policies: scientific, financial, contract, reporting, publications.
- Steering Committee (= programme com. of this meeting)

## 3- Contractual changes

#### **Changes in the consortium**

The following changes concerning some of the partners have occurred in the first 12 months:

- Austrian Research Centers (ARC, partner no. 2) has changed its name to **Austrian Institute of Technology (AIT).**
- 2. Gesellschaft fuer Schwerionenforschung (GSI, partner no. 15) has changed its name to Helmholtzzentrum fuer Schwerionenforschung (GSI).
- 3. Forschungzentrum Karlsruhe (FZK, partner no. 14) has merged into a new legal entity Karlsruhe Institute of Technology (KIT).
- Tampereen Teknillinen Yliopisto (TUT, partner no. 27) has changed its legal status and name to TTY-SAATIO (TUT).

As a result of these changes, Amendment no.1 to the EUCARD Grant Agreement has been implemented and approved by the EC on 10.3.2010. There are only administrative changes (i.e. names and acronyms) in the updated version of Annex I (Description of Work).









## 4- Distribution of the funding

| Date       | title                       | Amount<br>(Euros) | % of total EU budget |

| April 2010 | 2 <sup>nd</sup> installment | 1.56 <b>M€</b>    | 16%                  |

The payment of the second installment is conditional to:

- the approval of the progress or achievements of the milestones and deliverables by the GB (CA),
- the receipt of the documents on Use of Resources (difficult for S1, much better for S2)

Next fraction of the EC funding is expected around M23-24, upon acceptance of the 1st Periodic Report.








# 5- EuCARD dashboard – year 1

#### **Use of resources by Work Package**







# 6- Towards more sustainable accelerator R&D collaborations

EuCARD strategy: support of initiatives ("start-ups"), identification of synergies, insertion of EuCARD in a larger context.

- Medical accelerators: support to "Health for Physics" workshop with possible follow-up's in discussion,
- Plasma wave acceleration: support to a MPI initiative, discussions with LOA, follow-up expected.
- Contacts: ESGARD, USLARP, CERN, INFN, RAL, Lancaster U., Cesinvtav (Mexico), LOA, EC thru ECRI2010.

No specific budget foreseen in Annex 1. Some modest funds obtained from CERN (transfers from former EU projects after closing the books).









# 7- Management activities for next year

- 1. First exercise of periodic EC reporting in fall 2010: active collaboration and help expected from partners.
- 2. Follow up scientific results (visits,...)
- 3. Investigate the organization of events to bring together the communities of
  - Plasma wave acceleration
  - Medical accelerators

Goal: investigate synergies, possibly define common concrete objectives and need in infrastructures. Use the existing competences amongst the 37 EuCARD partners.









#### **Conclusions - 1**

From the completion of deliverables, milestones and publications, the EuCARD project appears on good tracks. We will hear more during the meeting.

A motivated coordination office and a number of SC meetings have allowed setting up an efficient internal collaboration and communication.

We plan to take new initiatives extending EuCARD to two new accelerator R&D fields.









#### **Conclusions - 2**

An important exercise is the periodic EC report from end of September 2010. The management shall need a proactive contributions from all tasks, WP and partners. The interim reporting should have trained all participants to the first periodic EC report to be delivered after Sept. 2010.

Soon after (April 2011), a mid-term review on scientific results will be carried out by the EC.
