- an overview of the progress towards the objectives of the action (including milestones and deliverables identified in Annex 1 and any possible deviations) and an exhausted view of the exploitation and dissemination of the results and an updated 'plan for the exploitation and dissemination of the results';
- a summary for publication by the Agency;
- the answers to the 'questionnaire', covering issues related to the action implementation and the economic and societal impact, notably in the context of the Horizon 2020 key performance indicators and the Horizon 2020 monitoring requirements;

→ a 'periodic financial report'

2. a **FINAL REPORT** within 60 days following the end of the last reporting period including the followings points:

- → a '<u>summary for publication'</u> containing:
- an overview of the results and their exploitation and dissemination;
- the conclusions on the action, and the socio-economic impact of the action;
- → a <u>'final financial report'</u> containing a 'final summary financial statement' (see Annex 4), created automatically by the electronic exchange system, consolidating the individual financial statements for all reporting periods and including the request for payment of the balance
