How to interpret this table

The percentage of proposals with a given score or higher is shown, per ranking list. Green shows the funding range.

For example:

-in the CHE ranking, 11.88% of all proposals submitted in the ranking list (total 160) scored 95 or higher. The funding cut off is between 95 and 96.

-in the ENG ranking, 11.72% of all proposals submitted in the ranking list (total 401) scored 94 or higher. The funding cut off is between 94 and 95.

-in the SOC ranking, 10.57% of the proposals scored less than 70.
