EDMS Features implemented for XLS

- Contexts
- Limited selection of available documents
- New e-groups for administration
- Two release procedures
- Commenting
- "Public, restricted document" document visibility





EDMS context

- Is a predefined "framework" or "template" with allowed release procedures, documents and user groups
- Can be changed and modified at any moment
- New documents have automatically preselected the correct context

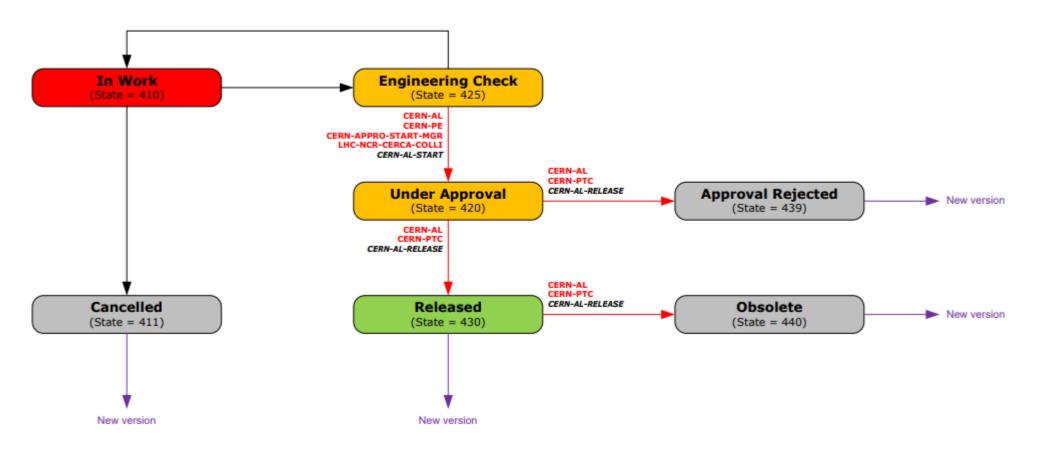

Commenting during approval process:

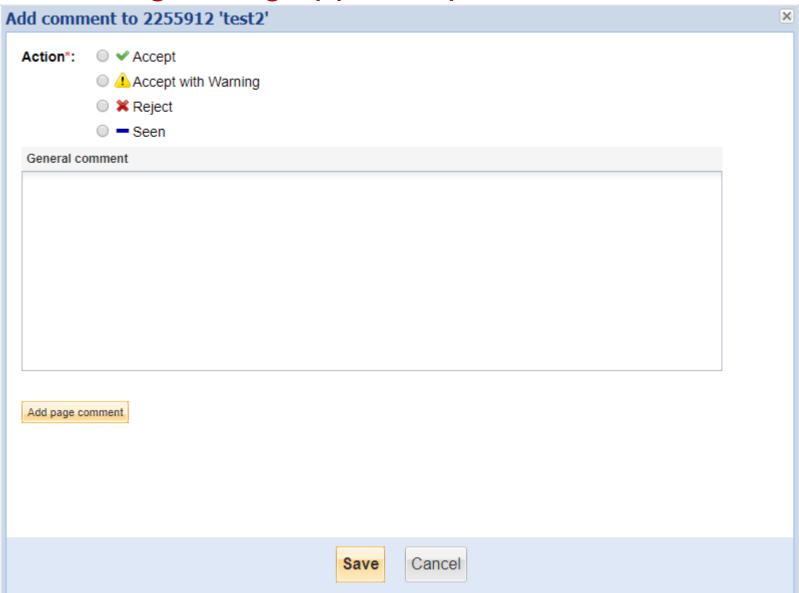

- Choose an action (mandatory)
- 2. Indicate which decision you take regarding the contents of the document:
- ✓ Accept: you accept the document. You may give some additional information if needed.
- Reject: there is something in the document you disagree with. You have to explain why you reject it (whether in the general comments or in the page comments). You have to explain the general reason in the general comments "Text" field.
- Seen: indicates that you did read the document but have nothing special to say about it. You may add some comments to explain why you have nothing to say (!).
- 3. Type your general comments (mandatory) in the general comments "Text" field.
- 4. You may want to enter some precise comments on a page. Type the number of the page in the page comments "Page" field. Type your page comments in the page comments "Text" field. It is possible to enter many different comments related to the same page. If you want to add some other comments related to some other pages, click on the "Add" button.
- 5. Save all your comments (general + pages) (mandatory).





Commenting during approval process:







Visibility of documents:

- "public access" (not available in PBS context)
 - not findable through external search engines but browsable and retrievable without CERN account
- "restricted" (default)
 - Findable without CERN account, but retrievable only for access group.
- "sensitive"
 - Not findable if you are not part of the access group

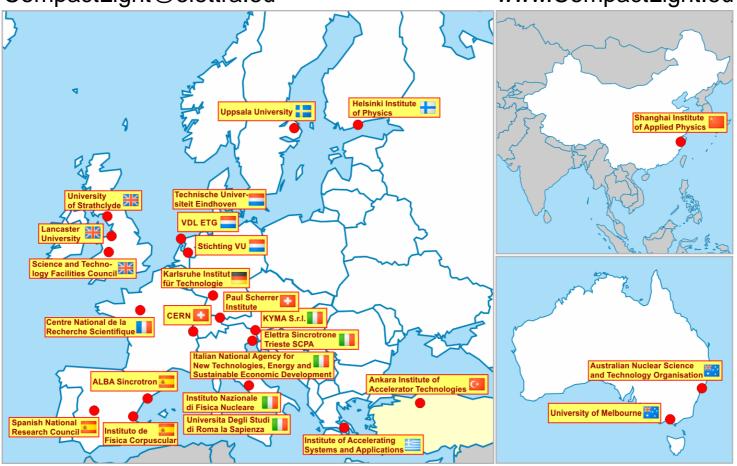
