- APEL Patch #1164 in certification (Maria Alandes Pradillo)
- Multiple CE support added,
- FQAN full tree extracted
- User-DN encryption fix
- Some enhancements to YAIM are required
 - to allow different CEs to write to the APEL database

Offline Processing of Accounting Data

■ User and VOMS Accounting

- Already seen CESGA portal and its implementation of the "Five Actors" model to provide restricted access to accounting summaries using ACLs.
- In order to deliver User-level and VOMS-level summaries, GOC must process accounting records after they have been published by the site
 - Extract from RGMA archiver, store in offline SSL secure database
 - decrypt User-DN
 - extract Group/Role from FQAN
 - Aggregate
- Status: Offline processor near completion, in testing.



SAM Tests

■ SAM Tests

- Determine which sites have NOT synchronised their accounting data with the GOC.
- Compares the data in the site's APEL database, to the data in the GOC's database
- Tests cannot tell us about sites that do not use APEL.
- Tests available as RSS feeds and ready to be published into SAM.



SAM Tests

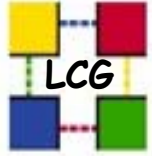
- Two tests available as RSS feeds and described in ApelFaq pages on GocWiki
- ApelSynchHist Test
 - Sites which have a significant GAP are in an ALERT state
- ApelLastPub Test
 - Sites which have not published accounting data in the
 - last 7 days are in WARNING state
 - Last 31 days are in ALERT state



SAM Tests

- ApelSynchHist
 - High-level summation across all VOs, similar to a checksum
- Status : to be published into SAM
