GUIDES TO VISIT SOUTH KOREA

No visa needed (K-ETA)

In this case you must still get an Electronic Travel Authorisation (K-ETA).

This is a light-weight procedure that can be done fully online, at least 72h before your travel.

Once approved it is valid for 2 years.

A visa is needed

This is the normal visa process and can take a longer time. It is important that you start your visa application as soon as possible.

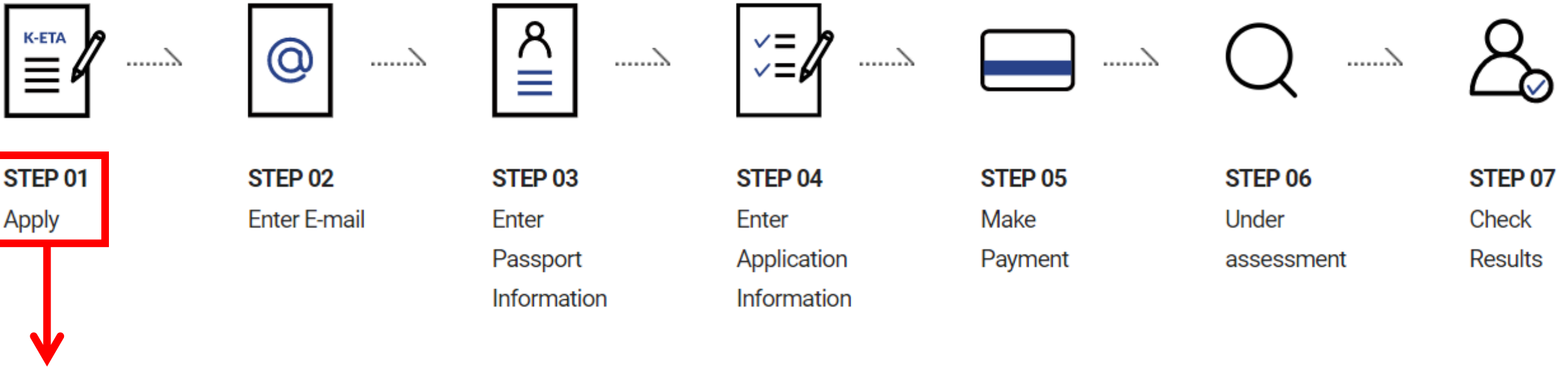

※ For PC, image file. For mobile application, photo take by mobile device camera during application

4. Credit or debit card that can be used to pay the fee.

※ The fee is 10,000KRW (approximately USD \$9~10) per person.

How to apply

- Embassy or consulate of the Republic of Korea under the jurisdiction of the country of residence (region)

Fee

- **\$40** based on short stay (within 90 days)

03) ITEM GUIDANCE

- Submission documents and forms might be different by country, **so you need to check them in advance**
- The guided submissions set out the minimum range of common standards applicable to each country
- For more accurate visa screening, submission documents might be added or exempted in consideration of the situation of the country of residence (region of jurisdiction)
- If you have any other questions, please contact Embassy or Consulate of the Republic of Korea (South Korea) in your country
- **Please apply in advance considering the screening period**
- If you have any documents to request, please contact us here (e.g Invitation Letter)

01) COMMON REQUIREMENT

STEP 1 Prepare a negative PCR or RAT result confirmation

- All overseas entrants are required to prepare a negative PCR test result taken within 48 hours of departure or RAT result taken within 24 hours. You may be denied access to boarding if you fail to show the test result during flight check-in.

STEP 2 Enter information on Q-CODE

- If you enter your information on Q-CODE prior to boarding, you can scan the QR code upon arrival at the quarantine checkpoint.

02) ENTRY PROCESS

STEP 1 Upon arrival at the airport, proceed to check temperature and submit documents at quarantine checkpoint

- Q-code applicants may use their pre-issued QR code instead of submitting printed documents (Fill out the Health Questionnaire and Travel Record Declaration. Not needed if you fill in Q-CODE)
- Required documents
 - ✓ Negative COVID-19 PCR Test Result Certificate or Rapid Antigen Test (RAT) Result
 - ✓ Health Questionnaire & Travel Record Declaration
 - ✓ Passport
- All documents above can be registered in advance via Q-code.

STEP 2 PCR test in Korea

- **All travelers are required to take a PCR test within 1 days after arriving in Korea**(Starting July 25, 2022). Short-term visitors can take a PCR test at the COVID-19 Testing Center inside the Incheon International Airport or at a nearby medical clinic at their own expense.
