A preliminary visit with BE/OP has been done the 11/06.




361 – Partial 2nd floor




Where: 361/2-004, 361/2-006 When: from 02/09/20 to 02/10/20 (once shaft closed)

What: Installation of new socket outlet boxes and new lighting system supplied from the existing EBD14*25A **Procedure:** Removal of the old infrastructure and installation of new equipment after the strip out. **Risks:** Activation of AUG button due to accidental human action. Trip of EBD1*25 (supply of EDD1*25A and EDD2*25A – normal supplies of BCER/BAT racks)

Where: ground floor of building 37 + 5m of 361/BATWhen: From 14/09/20 to 02/11/20What: Installation of new cabling, socket

outlets, lighting system, and a new switchboard for general services using the old supply (5m cable to be pulled in the 361/BAT)

Procedure: For the cable pulling in 361/BAT, the BSW converters have to be turned off and covered to protect the connectors. The strip out of the old EBD11*25B will be done in a future shutdown (as recommended by BE/OP). **Potential issues:** Need to relocate offices' users of bldg 37 during the works. Supply cable passes through Bldg. 361 near the BSW converters. Trip of EBD1*25 (supply of EDD1*25A and EDD2*25A – normal supplies of BCER/BAT racks)
