

Human race divisions and racism are insidious, real, social, facts.



- * "Whiteness" and its first privileges




The Mainland Colonies


- * The revolution lost

- * Institutions, Culture, Psychology








Left: Lynching of a black man, 1882. Photograph: Library of Congress/UIG via Getty Images

 - * The intentional (erasure) telling of who's history?
 - * Place-based education
 - * Organizing anti-(racism)(colonialism)

"...we must study how colonization works to decivilize the colonizer, to brutalize him in the true sense of the word... proceeding towards savagery. ...at the end of the blind alley which is Europe... at the end of capitalism... at the end of formal humanism and philosophic renunciation, there is Hitler. Colonization... dehumanizes even the most civilized man... [in] seeing the other man as an animal... [the colonizer] transform[s] himself into an animal [in a] boomerang effect of civilization... [it is] a law of progressive dehumanization... that cannot but bring about the ruin of Europe itself" (35-37, 41, 68, 75).
